- .1 Q Regarding submission of the tender, there is a "Sealed envelope" submission required and the bids & tenders "Online" format. Which submission format are we to use?

A – Tenders shall be submitted through the Online format.

.2 Q – Page (18) of the tender documents states the breakdown is to be submitted in "(2) working days" but the breakdown form notes, "24 Hour" submission. Please advise.

A – Refer to the amended Form of Tender 2.4 attached.

.3 Q –2.1 Schedule of items & Prices, Item 3- are we to plug the PSI value here?

A – The contractor shall acknowledge the Preselected Equipment value and acceptance of the Novation requirements by inserting the preselected equipment value (Item into the Schedule of Items & Prices (2.1) Item 3.

.4 Q – Regarding the Itemized Breakdown, there are several divisions noted but not included in the specification package. We kindly ask that these items be removed to avoid any potential confusion.

A – Refer to the amended Form of Tender 2.4 attached.

.5 Q – On drawing E2.3, there are references to E3.4 and E3.5 under the description of items in the MCC. Is this a reference to those drawings? If, yes, drawings E3.4 and E3.5 are not in the Drawing package.

A – These are typos. These references are intended to point to the corresponding control schematics for each piece of equipment (namely E2.3 and E2.4). Replace references to E3.4 and E3.5 with E2.4 and E2.5 respectively.

.6 Q – Detail 11/S1.3 type 3 repair says to refer to detail 7/S1.3 for repair detail and there is no repair detail for the type 3 repair on 7/S1.3

A – The repair detail in 7/S1.3 for Type 3 – Concrete Cracks is the written description at the bottom (no image).

.7 Q – Detail 7/S1.3 states that the quantities described above are estimated for the entire area of Clarifier 2 in addition to the quantities described in section 8/S1.3 and 11/S1.3.

There is no quantity listed on 8/S1.3. Is the expansion joint repair to be listed as a Type 1 repair? If so what is the total length of all the expansion joints to be repaired. Partial depth concrete removals and repairs should not be a LS price or included in a LS value.

A – In regards to Type 1,2 and 3 concrete repairs, allow for the quantities noted at the bottom of detail 7/S1.3 plus the quantities noted in detail 8/S1.3, 11/S1.3 and Item 4 on S1.1 and S1.2 (inlet channel wall). Note there is also an allowance for provisional Type 1, 2, and 3 repairs in addition to above.

The total length of all the expansion joints to be repaired (Primary Clarifier No. 2 - base bid) is approximately 37m for the baseslab joint repair (with concrete repair), and 66m for the wall joint repair. Provisional items include 13m of baseslab expansion joint repair (with concrete repair) and 22m of wall expansion joint repair in Primary Clarifier No. 1. The contractor shall bid based on the

assumed Concrete Repair Type 1,2, and 3 quantities indicated on the drawings. The unit prices entered in the Form of Tender – 2.2 Schedule of Provisional Items will be used to adjust the contract LS amount based on actual repair quantities for concrete repair types 1,2, and 3.

.1 P2: Provide lump sum pricing for Primary Clarifier No.1 baseslab and wall expansion joint repairs – Items 5* and 6* on S1.1 and S1.2. The approximate length of baseslab and wall expansion joint repairs in Primary Clarifier No. 1 is 13m and 22m respectively. Refer to Detail 8/S1.3 Base Slab and Expansion Joint Repairs and Detail 10/S1.3 Wall Expansion Joint Repair Detail.
